

# Sonoma County Family YMCA School Recreation Program

## 2026/2027 Fee Explanation

### Sebastopol

There is an annual \$65 Registration Fee (\$45 for each additional child) to sign up for the Sonoma County Family YMCA School Recreation Program (Registration Fee entitles each child to Program Member rates for all Y programs). When you enroll your child (ren), you are reserving the time, space, staffing and program materials for your child whether they attend or not.

#### **What are the Options available?**

**TK/Kindergarten Time:** Y staff will pick up your kinder from their classroom at TK/K dismissal time and walk them to the Y program. This option covers the time from TK/K dismissal until all grades are dismissed at the end of the school day. If you need care from the end of the school day for all grades, please register for the Afterschool option as well.

**Afterschool:** The program covers care from when school is dismissed for all grades and is open until 5:30PM.

**Flex Plans:** 10, 20, or 30 hours per month to use as needed, if space is available. Hours must be used in hour increments.

**Afterschool option** includes care on minimum days (no extra charge) if it falls on a day for which you're contracted. If you need care on a minimum school day and it is on a day you are not contracted for, care will be provided if space is available and an additional fee will be charged. K time and Flex options can add care on a minimum day if space is available for an additional charge.

#### **What if I need care on non-school days?**

If you need care on a non-school day you may sign up if space is available for an additional fee. Full Day fees are ***\$65/day***. Charges for this care will be added to your account the following month and will be due on the 1<sup>st</sup> of the month thereafter. If you need this additional care, prior arrangements must be made with your Site Director. Summer Camp is a different program. Our Summer Camp brochure is released in February and includes fee and registration information.

#### **What if I want to make a schedule change?**

Schedule changes must be made at least two weeks prior to change going into effect. Only two schedule changes per school year are allowed. To make a change send an email to [childcare@scfymca.org](mailto:childcare@scfymca.org).

#### **Additional Information**

- There are no credits for missed time except in the case of an extended illness (minimum of 5 consecutive days in one month and verified by doctor notice).
- Sibling Discount: additional children receive 10% discount off the contracted rate only and it is deducted from the lowest fee. This does not apply to additional care used within the month. This does not apply to flex plans.
- If additional hours are needed over contracted time they will be billed at ***\$18/hr***. Charges for this care will be added to your account the following month and will be due on the 1<sup>st</sup> of the month thereafter.
- Financial Assistance is available on a sliding scale. Please email [childcare@scfymca.org](mailto:childcare@scfymca.org) for more information or to apply. ELOP qualified families receive care at no charge.**
- Payments are due by the first (1<sup>st</sup>) of the month. A \$25 fee will be assessed for late payments. Please refer to financial agreement for more info.

**2026/2027 Monthly Rates**

The rates have been calculated by total school days in the school year and divided into a monthly fee. The Monthly Rate for your plan is the same each month no matter how many school days in that month. Rates are for all school days and include minimum days. Non-school days are billed separately at \$65/day. Financial assistance is available. ELOP families receive care at no charge. Must qualify for ELOP through the school.

**TK/K and Afterschool Plans**

Flex Plan hours can be used throughout the month as needed and if space is available. Check with Site Director before using care to see if space is available and so that staff know to expect your child(ren). Hours will be deducted in 1 hour time blocks, until all pre-paid hours have been used. Any unused hours will not be carried over to the next month or credited to your account. After all pre-paid hours have been used, additional hours will be billed at a rate of **\$18/hr** with a 1 hour minimum per visit. Sibling discounts do not apply to flex plans.
